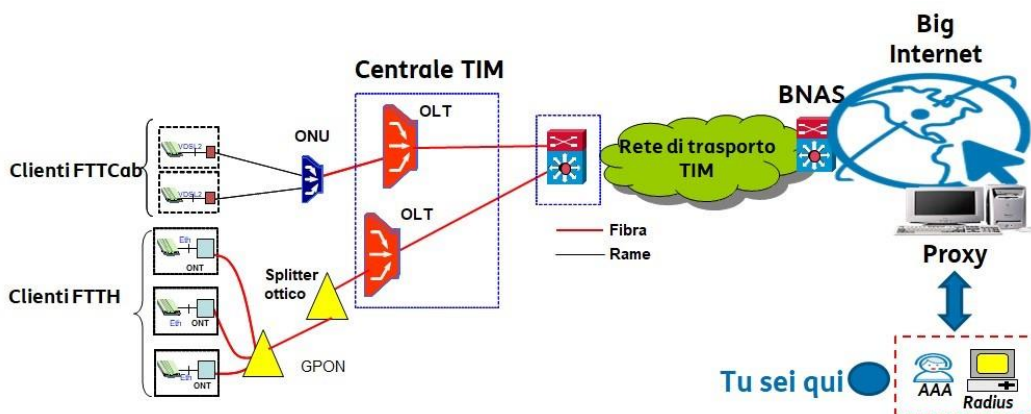

Getting Started

After signing the contract, you must:

- Test the initial configuration for the dialogue between the Telecom Italia Proxy and your Radius server;
- Ask us to provide access to ultra-wideband, FTTCab or FTTH, from your Customers' locations. You can ask us to create a new line or create a 'migration', a passage of the Customer from another Operator (OAO).
