## **SEMI-Bitstream NGA**

With Semi-Bitstream NGA you can offer Bitstream NGA FTTH, with the cost advantages of FiberCop co-investment.

#### Service characteristics

#### Who is it for?

Semi-Bitstream NGA is the ideal solution if:

- you already use Bitstream NGA
- you have participated in the co-investment with FiberCop project
- you want to collect the accesses in the municipalities involved in co-investment on the same Bitstream NGA, CAR and VLAN delivery kits already in your possession

#### **Preliminary services**

- Co-investment contract with FiberCop (Semi-GPON with guaranteed minimum)
- <u>Bitstream NGA</u>

#### **Description of Semi-Bitstream NGA service**

With the Semi- Bitstream NGA service, we collect FTTH access traffic you have coinvested in and deliver it onto your Bitstream Kit, and if you like, also with the VLANs you are already using to collect other Bitstream NGA accesses in the same exchange.

To receive the Semi-Bitstream NGA service, you must therefore:


•activate the Bitstream NGA service

•have participated in the Co-investment with FiberCop project (Semi-GPON service with guaranteed minimum) to use passive connections on the secondary fibre optic network, from the end customer site up to the FiberCop optical cabinets (CRO/CNO).

TIM will be responsible for End to End management of the supply and support processes, invoicing and SLAs/penalties (also for the components that FiberCop is responsible for) (End to End Semi-Bitstream NGA).

### **SEMI-Bitstream NGA**

Like the Bitstream NGA service, Semi- Bitstream NGA also has 3 components: **delivery**, **transport** and **access**, but the transport and delivery components are those of the <u>Bitstream NGA</u> service



#### <u>Access</u>

This is the FTTH connection between the end customer site and the TIM exchange by way of:

- Semi-GPON connection purchased from FiberCop;
- shared use of the TIM primary fibre optic network from the FiberCop CRO/CNO cabinets to the TIM OLT site;
- supply of the ONT to the end customer site.

#### **Getting started**

You must have:

- signed the Bitstream NGA contract: you must do this to request the NGA kits and VLANs in the exchange where your accesses are delivered (if you don't already have them);
- signed the Co-investment with FiberCop contract.

You can ask us to supply a new Semi-Bitstream NGA line or effect a "migration", i.e. the customer is transferred from another Operator (OAO).
